WARRANTY DEED

hereinafter called grantee, does hereby grant, bargain, sell and convey unto the grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

The south $\frac{1}{2}$ off lot 6 in block 6 of Altamont acres and that portion of lots 7, 8, and 9 in block 6 of Altamont acres lying east and north of the U.S.R.S. Laterall A-3-C, according the official Plat thereof on file in the office of the county clerk of Klamath County, Oregon. Excepting therefrom the western 3 feet for the widening of Bisbee Street.
