5. FINDINGS

The Hearings officer FINDS AS FOLLOWS:

- a. The development of a second of structure is not included in the permitted uses for this zoning.
- b. The LDC permits second resider ces only on parcels of over 10 acres.
- c. Approval of the requested structure will create conditions or circumstances that are contrary to the purposes or intent of county planning laws.
- d. There is no dwelling presently shed on this pancel but applicant wishes to build a stick home on the property and reside in the trailer until the stick built home is completed.

6. ORDER

Therefore, it is hereby ordered that the applicants request to develop a second residence on her 10 acres is denied. However, applicant is permitted to install a temporary trailer, mobile or other structure without a permanent foundations, and on a temporary basis while she builds her home subject to the following conditions:

- That any structure lie temperary in nature and not be located on the property more than 30 days after the stick built hone is completed.
- b. Than in no case shall a temporary dwelling be located on the property past July 30, 1999.

c. That a temporary structure shall only be permitted during the adjual construction of the permanent structure and only for the occupancy of applicant and her immediate family.
