

This Indenture Witnesseth, THAT R. A. COFFMAN and MARY R. COFFMAN, husband and wife, hereinafter known as grantors, for the consideration hereinafter stated have bargained and sold, and by these presents do grant, bargain, sell and convey unto L. A. GRATZER and PEGGY P. GRATZER, husband and wife, grantees, the following described premises, situated in Klamath County, Oregon, to-wit:

A portion of Lots 5 and 6 in Block 45 of NICHOLS ADDITION to the City of Klamath Falls, Oregon, described as follows:

Beginning on the Easterly line of Tenth Street at the Southwesterly corner of said Lot 5; thence Northwesterly along said line of Tenth Street 40 feet to a point; thence Northeasterly at right angles to Tenth Street 133.66 feet, more or less, to a point on the Easterly line of said Lot 6; thence Southeasterly along said Easterly line of Lot 6, 15 feet to a point; thence Southwesterly and parallel to the Southerly line of said Lot 6, 36.56 feet to a point; thence Southwesterly and parallel to said Tenth Street, 15 feet to a point; thence Southwesterly and parallel to the Southerly line of said Lots 5 and 6, 40 feet to a point on the Southerly line of Lot 5; thence Southwesterly along the Southerly line of said Lot 5, 57 feet, more or less, to the place of beginning.

SUBJECT TO: Sewer and water charges, if any, due to the City of Klamath Falls; Reservations, restrictions, easements and rights of way of record and those apparent on the land, if any.
