- An Indenture was made and entered into on the 17th day of August, 1943 by and between GILCHRIST TIMBER COMPANY, a Delt ware corporation and THE SHEVER-HIXON COMPANY, a Delaware corporation. The Indenture was recorded in Klamath County, Oregon on October 25, 1943 at Volume No. 159, page 300, Microfilm Records of Klamath County, Oregon.
- 2. CROWN PACIFIC LIMITED PARTNERSHIP, Delaware Limited Fartnership, is the successor in interest to the GILCHRIST TEMBER COMPANY and THE SHEVLIN-HEXON COMPANY, a Delaware corporation.
- 3. The Indenture grants rights-of-war, for the purpose of hauling, transporting, carrying over the same, logs, lumber and other forest products, materials, and supplies used in the logging operations of the parties to the Agreement.
- 4. The Indenture states "...that if the title to any partiel of real property included in the description hereinbefore set forth is conveyed to the United States of America, then all rights herein granted shall, insofar as such rights may involve said parcel of real property, immediately cease and terminate upon the acceptance of title to the said parcel by the United States except that rights in pursuance to which road [sic] have been actually constructed as of the date of the acceptance of title by the United States shall not so cease and terminate;..."
- 5. CROWN PACIFIC LIMITED PARTNERSHIP, as a successor interest to the Grantor and Grantee, by this document, terminates the 1 identure referred to above. It is the intent of this document that, effective upon signing, the indenture is terminated for all purposes, including terminating the language set forth in paragraph 4 above, and upon signing this Termination the indenture shall not effect the real property of CROWN PACIFIC LIMITED PARTNERSHIP in Klamath County, Oregon.
