 the County of KLAZATH and State of Oregon, to wit:







**LEGAL DESCRIPTION**

A portion of the NE1/4 SW1/4, Section 3, Township 36 South, Range 6 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Starting from the Northwest corner of the NE1/4 SW1/4 Section 3, Township 36 South, Range 6 East of the Willamette Meridian; thence South 89 degrees 50' East a distance of 60.05 feet; thence South 2 degrees 36' 12" West, a distance of 485.33 feet; thence East a distance of 236.99 feet to an iron pin, the point of beginning; thence South a distance of 125 feet to an iron pin; thence East a distance of 100.97 feet to an iron pin; thence North 18 degrees 47' 58" West a distance of 132.04 feet to an iron pin; thence West a distance of 58.42 feet more or less, to the point of beginning.

ALSO

Starting from the Northwest corner of NE1/4 SW1/4, Section 3, Township 36 South, Range 6 East of the Willamette Meridian; thence South 89 degrees 50' East a distance of 60.05 feet; thence South 2 degrees 36' 12" West a distance of 610.46 feet; thence East a distance of 214.16 feet to an iron pin, the point of beginning; thence South 12 degrees 06' 40" East a distance of 91.15 feet to an iron pin; thence North 77 degrees 53' 20" East a distance of 60.90 feet to an iron pin; thence Northeasterly on the Northerly side of the County Road, along a curve left having a radius of 543 feet; a distance of 63.39 feet to an iron pin; thence North 18 degrees 47' 58" West a distance of 62.80 feet to an iron pin; thence West a distance of 119.49 feet more or less to the point of beginning.
