KNOW ALL MEN BY THESE PRESENTS, that ROBERT D. The undersigned hereby certifies that no assignments of the trust deed by the trustee or by the beneficiary and no appointments of a successor-trustee have been made except as recorded in the mortgage records of the county or counties in which the above described real property is situate; further, that no action has been instituted to recover the debt, or any part thereof, now remaining secured by the said trust deed, or, if such action has been instituted, such action has been dismissed.

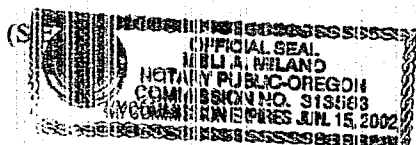
and the words "trustee" and "beneficiary" include their respective successors in interest, if any.
