CONSENT AGREEMENT

WHEREAS, CenturyTel of Eastern Oregon, Inc. dba CenturyTel, hereinafter called the Corporation, has need to construct, operate, and maintain a buried communications cable and the necessary appurtenances thereto within the Government's easement.

NOW THEREFORE, the Government consents to the construction, operation, and maintenance of said cable and appurtenances within the Government's easement, subject to the following conditions.
