TO ALL PERSONS, be it known, that I, LINDA Aileen DEAN CARRUTHERS DOB: 4-29-56 of 433 North 10th St #6 Klamath Falls, Or SSN: 554-08-6873 as Grantor, do hereby make and grant a limited and specific power of attorney to Robert C. Purkhiser [et al.] of 1948 MADISON ST. Klamath Falls, Or and appoint and constitute said individual as my attorney-in-fact.

My named attorney-in-fact shall have full power and authority to undertake, commit and perform only the following acts on my behalf to the same extent as if I had done so personally; all with full power of substitution and revocation in the presence: (Describe specific authority) to wit: Grant said forth Power of ATTORNEY re: JONATHAN CARL DEAN DOB 3-4-81 [A MINOR CHILD] TO ACT IN MY STEAD, REGARDING ANY LEGAL or CIVIL RESPONSIBILITIES re: said minor child Jonathan Carl DEAN. This exclusively covers all to wit: all scholastic, medical and emergency medical parameters. The only MATTER THAT IS NOT TO BE CONSTRUED as legal is Guardianship longer than 1 year from this date [to wit] March 21, 1997. At the end of 1 yr. March 21, 1998, this said Power of Attorney will either be ratified or rescinded by my hand in writing. Until said date this document is legal + binding to both parties. to wit: LINDA Aileen Dean Carruthers (Grantor) and Robert C. Purkhiser [et al.] [Nothing Follows.]

The authority granted shall include such incidental acts as are reasonably required or necessary to carry out and perform the specific authorities and duties stated or contemplated herein.

My attorney-in-fact agrees to accept this appointment subject to its terms, and agrees to act and perform in said fiduciary capacity consistent with my best interests as my attorney-in-fact deems advisable, and I thereupon ratify all acts so carried out.

I agree to reimburse my attorney-in-fact all reasonable costs and expenses incurred in the fulfillment of the duties and responsibilities enumerated herein.

Special durable provisions:

(1) This power of attorney shall not be affected by disability of the Grantor. This power of attorney may be revoked by the Grantor giving notice of revocation to the attorney-in-fact, provided that any party relying in good faith upon this power of attorney shall be protected unless and until said party has either a) actual or constructive notice of revocation, or b) upon recording of said revocation in the public records where the Grantor resides.

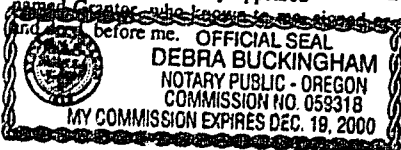
