DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated August 17, 1990; December 29, 1995, executed and delivered by Rollie H. 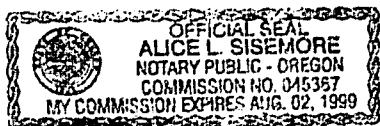
