- c. The parcel in question was legally created, but it was created n 1991 and does NOT qualify as A LOT OF RECORD under LRMP 55.070(B)(1).
- d. The Lot of Record provisions require not only that the land has been owned since before 1985 but that the parcel in question have been created before that date as well. The ownership of this land dates back more than enough, but the parcel is too new.
