DEED OF RECONVEYANCE

KNOW ALL BY THESE PRESENTS that the undersigned trustee or successor trustee under that certain trust deed dated MAY 17, 1994, executed and delivered by KLAMATH PACIFIC CORPORATION, AN OREGON CORPORATION, as grantor and recorded on JUNE 9, 1994, in the Records of KLAMATH County, Oregon in book/reel/volume No. M94 at page 18084, and/or as fee/file/instrument/microfilm/reception No. 82482 (indicate which), conveying real property situated in that county described as follows:

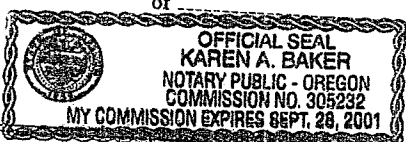
