## EXHIBIT "A" DESCRIPTION OF PROPERTY

A tract of land situated in the S  $\frac{1}{2}$  SE  $\frac{1}{4}$  SE  $\frac{1}{4}$  of Section 8, Township 39 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon, being a portion of the S  $\frac{1}{2}$  SE  $\frac{1}{4}$  SE  $\frac{1}{4}$  of said Section 8, lying East of an existing graveled road described in Deed Volume M75, page 15158, Microfilm records of Klamath County, Oregon, and being more particularly described as follows:

Beginning at the Northeast corner of the S  $\frac{1}{2}$  SE  $\frac{1}{2}$  SE  $\frac{1}{2}$  of said Section 8; thence South 01°06'22" West 75 feet; thence South 75°51'11" West, 747.04 feet more or less to the centerline of said existing graveled road; thence along the centerline of said existing road the following courses: Northerly along the arc of a curve to the left (radius - 500.00 feet, central angle = 25°08'35") 219.41 feet; thence along the arc of a curve to the left (radius - 500 feet, central angle = 01°42'00") 14.84 feet; thence North 31°16'01" West 57.18 feet more or less to the North line of the S  $\frac{1}{2}$  SE  $\frac{1}{2}$  SE  $\frac{1}{2}$ ; thence South 87°31'08" East 833.01 feet along said North line to the point of beginning.
