Statement are Property. Lender may enter upon the Property to resintain the Property and keep the same in repair; to pay the costs thereof and of all services of all employees, including that equipment, and of all continuing costs and expenses of maintaining the Property in proper repair and condition, and also to pay all laxes, assessments and water utilities, and the premiums on fine and other insurance effected by Lender on the Property.

Inactivency. The dissolution or termination of Grantor's existence as a going business, the insolvency of Grantor, the appointment of a receiver for any part of Grantor's property, any assignment for the benefit of creditors, any type of creditor workout, or the commencement of any proceeding uncker any bankruptcy or insolvency laws by or against Grantor.

Lender shall have the right, without notice to Grantor, to take possession of the Property and collect the Rents, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the Indebtedness.
