All wells shall be equipped with an access port or airline so that static water level information can be determined at any time. 3 Well casing must be protected from damage and meet minimum extension requirements. Wells may only be permanently abandoned by a licensed and bonded well constructor or a landowner with a valid permit and bond. Well abandonment must be carried out in accordance with state rules.
