DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated September 12, 1996; November 8, 1996, executed and delivered by Alan C. 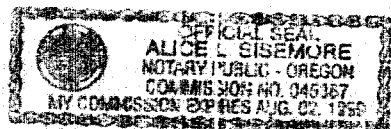
