DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated June 24, 1992, executed and delivered by Ron D. McCutcheon & Susan P. 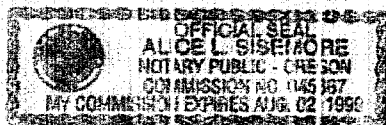
