

Excepting and reserving to itself, its successors, and assigns all minerals, as defined in ORS 273.775, (Excepting soil, clay, stone, sand, and gravel), and all geothermal resources, as defined in ORS 522.005 together with the right to make such use of the surface as may be reasonably necessary for exploring for, mining, extracting, storing, drilling for, and removing such minerals, materials, and geothermal resources.
