## DEED OF RECONVEYANCE

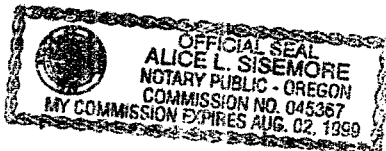
