

**MEMORANDUM OF LAND SALE AGREEMENT**

In Witness Whereof the said vendor has executed this Memorandum November 18, 1998.

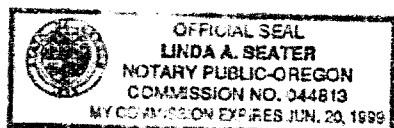
