In Witness Whereof the said vendor has executed this Memorandum November 23, 1998.

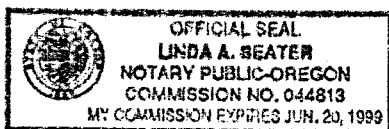
