FINDINGS

After hearing testimony and looking at the exhibits the hearings officer finds as follows: That the applicant has made significant progress in getting the area cleaned up and

sanatary.

That the applicant still needs to continue making progress.

That given a bit of time it is the hearings officer's expectation and hope that the problems can be resolved without further orders or proceedings.

ORDER

Therefore, it is hereby ordered that the applicants request to develop a pre-1976 Mobilchome is approved subject to the following conditions:

- a. That approval is obtained for on-site sewage disposal and that the applicant provides proof of clearance from the Environmental Health Services Division and Building department within two (2) years following the date of this order, or obtain an extension of time, or this approval will be void.
- b. That all required building and placement permits or an extension of time be obtained within two
 (2) years following the date of this order or this approval will be void.
- c. Applicants must obtain legal sewerage and an approved septic system by May 1, 1999. In the interim if applicant can show that they have a sanitary above ground system which is being regularly serviced he may allow occupancy. Who resides there is up to the applicant, but it shall in no event be used as a rental.
- d. Applicants shall have the yard cleaned up and landscaped by June 1, 1999.
- e. The applicant shall make all reasonable efforts to have surplus building materials and supplies covered and contained by spring, 1999.
