DISTRIBUTION RIGHT OF WAY EASEMENT

For value received <u>Clee Crawford & Shirley Crawford</u> (Grantor) hereby grants to PacifiCorp, an Oregon corporation, its successors and assigns (Grantee), an easement for a right of way <u>20</u> feat in width for the construction, reconstruction, operation, maintenance, repair, replacement, enlargement, and removal of electric power distribution lines and communication lines and all necessary or desirable accessories and appurtenances thereto, including without limitation: supporting towers, poles, props, guys and anchors, including guys and anchors outside of the right of way; wires, fibers, cables and other conductors and conduits therefor; and pads, transformers, switches, vaults and cabinets, along the general course now located and staked out by the Grantee on, over or under the surface of the real property of Grantor in <u>Klamath</u> County; State of <u>Oregon</u>, more particularly described as follows and by this reference made a part hereof:
