DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated March 19, 1997; May 30, 1997, executed and delivered by Donald K. 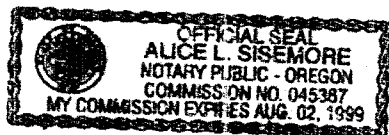
