THIS MATTER COMING ON AT THIS TIME TO BE HEARD before the
Klamath County Board of Commissioners and it appearing that said
Commissioners under ORS 570.525 may declare noxious weeds which
are to be destroyed and prevented from producing seed within the
county, and

IT FURTHER APPEARING that the Board of Commissioners has
identified the following weeds of known economic importance in the
County in small enough infestations to make eradication
practicable or, if not known to occur, its status in surrounding
Counties makes future occurrence seem imminent, and therefore
shall be subject to eradication where found:

Johnsongrass	Skeletonweed
Leafy Spurge	Tansy Ragwort
Mattgrass	Teasel
Mediterranean Sage	Dalmatian Toadflax
Musk Thistle	Yellow Starthistle

Russian Knapweed	St. Johnswort

eradication as local conditions warrant:






