DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated July 2, 1979; October 3, 1996, executed and delivered by Wayne A. 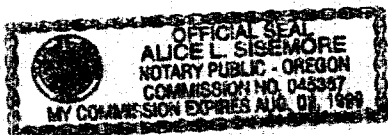
