KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated August 13, 1996, executed and delivered by Patrick M. Nugent & Susan B. 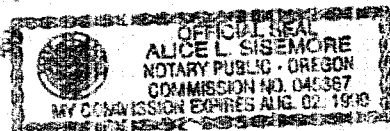
