KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated May 11, 1993, executed and delivered by Leon A. Buzzard & Susan E. 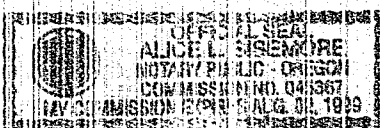
