On November 13, 1997 the board properly served notice on Donald Williamson (hereinafter WILLIAMSON) that it intended to issue a civil penalty in the amount of \$5,000 for violation of ORS 701.055(1). The Notice further granted to WILLIAMSON an opportunity for hearing, if requested within 21 days of service of the Notice. No such request for hearing has been received by the board. The Notice designated the board's file on this matter as the record for purposes of default.

FINDINGS OF FACT

1. On or about July 5, 1997, WILLIAMSON was not registered with the Construction Contractors Board. There is no record of registration for WILLIAMSON.
2. On or about July 5, 1997, WILLIAMSON entered into a contract with Richard and Donna Rocca to re-roof one half of their house, located at 346 N. Tenth, Klamath Falls, Oregon. The contract amount was \$650. WILLIAMSON received \$200 as a down payment. The work started on July 5th and stopped on July 30, 1997. The job was not completed.

ULTIMATE FINDINGS OF FACT

WILLIAMSON performed work as a contractor on or about July 5, 1997 in the state of Oregon while not properly registered with the CCB.

CONCLUSION OF LAW

WILLIAMSON violated ORS 701.055(1) by performing as a contractor while not registered with the Board.

ORDER

It is ordered that WILLIAMSON pay a civil penalty in the amount of \$5,000.

APPEAL RIGHTS: You are entitled to judicial review of this order in accordance with ORS Chapter 183.480. You may request a judicial review by filing a petition with the Court of Appeals in Salem, Oregon, within 60 days from the date of this order. Tape recordings of Administrative Hearings are retained 90 days after the date of the final order. Duplicate tape recordings cost \$10 per tape.
