On August 21, 1998, the board properly served notice on Shawn Earnest Johnson (hereinafter JOHNSON) that it intended to issue a civil penalty in the amount of \$5,000 for violation of ORS 701.055(1). The Notice further granted to JOHNSON an opportunity for hearing, if requested within 21 days of service of the Notice. No such request has been received at the Board. The Notice designated the board's file on this matter as the record for purposes of default.

FINDINGS OF FACT

1. JOHNSON'S registration was suspended on December 31, 1997.
2. On or about October 5, 1997, JOHNSON entered into a contract with Roy Kring to build a pole building at 5201 Starlit Ct., Klamath Falls, Oregon. The work continued until March 12, 1998, after JOHNSON'S registration was suspended. The work resulted in a claim filed with the board on April 1, 1998. JOHNSON received approximately \$4,160 for the work.

ULTIMATE FINDINGS OF FACT

JOHNSON worked as a contractor after his registration was suspended.

CONCLUSION OF LAW

JOHNSON violated ORS 701.055(1) by working as a contractor while not registered with the Board.

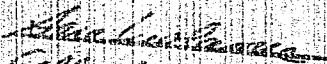
ORDER

JOHNSON is ordered to pay a civil penalty in the amount of \$5,000.

If you have any questions about payment or wish to make payment arrangements, please call 378-4621. Make checks payable to the Construction Contractors Board.

APPEAL RIGHTS: You are entitled to judicial review of this order in accordance with ORS Chapter 183.480. You may request a judicial review by filing a petition with the Court of Appeals in Salem, Oregon, within 60 days from the date of this order. Tape recordings of Administrative Hearings are retained 90 days after the date of the final order. Duplicate tape recordings cost \$10 per tape.
