On January 30, 1998, the Board properly served notice on Shawn Earnest Johnson (hereinafter JOHNSON) that it intended to assess a civil penalty in the amount of \$5,000 for failing to return his current registration pocket card. The Notice further granted to JOHNSON an opportunity for hearing, requested within 21 days of service of the Notice. A hearing was requested on February 17, 1998, and held on July 22, 1998.

FINDINGS OF FACT

The Board finds that JOHNSON violated ORS 812-003-1000(6)(c), based on consideration of the findings of an Administrative Hearing held July 22, 1998, a copy of which is attached.

ORDER

It is ordered that JOHNSON pay a civil penalty in the amount of \$5,000.

APPEAL RIGHTS: You are entitled to judicial review of this order in accordance with ORS Chapter 183.483. You may request a judicial review by filing a petition with the Court of Appeals in Salem, Oregon, within 60 days from the date of this order. Tape recordings of Administrative Hearings are retained 90 days after the date of the final order. Duplicate tape recordings cost \$10 per tape.
