On January 30, 1998, the Board privately served notice on Shawn Ernest Johnson (hereinafter JOHNSON) that it intended to assess a civil penalty in the amount of \$5,000.00 on JOHNSON an opportunity for hearing, requested within 21 days of service of the Notice. A hearing was requested on February 17, 1998 and held on July 22, 1998.

FINDINGS OF FACT

The Board finds that JOHNSON violated ORS 812-003-000(6)(c), based on consideration of the findings of an Administrative Hearing held July 22, 1998, a copy of which is attached.

It is ordered that JOHNSON pay a civil penalty in the amount of \$5,000.
