On October 16, 1997 the board properly served notice on Shawn Earnest Johnson dba Shawn Johnson Construction (hereinafter JOHNSON) that it intended to issue a civil penalty in the amount of \$1,000 for violation of ORS 701.055(1). The Notice further granted to JOHNSON an opportunity for hearing, if requested within 21 days of service of the Notice. No such request for hearing has been received by the board. The Notice designated the board's file on this matter as the record for purposes of default.

FINDINGS OF FACT

1. On September 30, 1997, JOHNSON's registration, number 111641, was inactive due to a lapse in insurance coverage.
2. On or about September 30, 1997, JOHNSON contracted with Elaine Herman at 315 N. Monroe, Merrill, Oregon, to re-roof a small house. JOHNSON received \$900 for a deposit for materials and to start up construction. JOHNSON did not perform any work and has failed to return the deposit.

ULTIMATE FINDINGS OF FACT

JOHNSON acted as a contractor on or about September 30, 1997 in the state of Oregon while not properly registered with the CCCB.

CONCLUSION OF LAW

JOHNSON violated ORS 701.055(1) by acting as a contractor while not registered with the Board.

ORDER

It is ordered that JOHNSON pay a civil penalty in the amount of \$1,000.

**APPEAL RIGHTS:** You are entitled to judicial review of this order in accordance with ORS Chapter 183.480. You may request a judicial review by filing a petition with the Court of Appeals in Salem, Oregon, within 60 days from the date of this order. Tape recordings of Administrative Hearings are retained 90 days after the date of the final order. Duplicate tape recordings cost \$10 per tape.
