FINDINGS OF FACT

1. Between the period of May 20, 1997 and July 7, 1997, JOHNSON's registration number 111641, was active.
2. Between the period of May 20, 1997 and July 7, 1997, JOHNSON contracted with Lee's Listings Inc. and Pamela Lee to construct a carport at 3950 Homedale #39 in Klamath Falls, Oregon. JOHNSON received \$1,500 as a deposit. No work was performed, and the deposit was not returned.
3. Between the period of June 11, 1997 and July 7, 1997, JOHNSON contracted with DeWayne Smith to construct a pole building at 3950 Homedale #39 in Klamath Falls, Oregon. JOHNSON received \$1,700 as a down payment. No work was performed, and the deposit was not returned.

JOHNSON is ordered to pay the board the amount of \$2,000.
