PAUL S. COSGROVE, SUCCESSOR TRUSTEE, HEREBY GIVES NOTICE OF DEFAULT AND ELECTION TO SELL: Reference is made to that certain trust deed made by Judith A. Preslar as grantor, to Ameritile as trustee, in favor of Associates Financial Services Company of Oregon, Inc., as beneficiary, dated May 15, 1997 recorded May 16, 1997 in the mortgage records of Klamath County, Oregon, in Book 24-97 at page 15182 as recorder's fee no. 37839, covering the following described real property situated in said county and state, to-wit:

The undersigned hereby certifies that no assignments of the trust deed by the trustee or by the beneficiary and no appointments of a successor trustee have been made except as recorded in the mortgage records of the county or counties in which the above-described real property is situated, further, that no action has been instituted to recover the debt, or any part thereof, now remaining secured by the trust deed, or, if such action has been instituted, such action has been dismissed except as permitted by ORS § 735(4).


