
And also for me and in my leases, mortgages, hypothecations, releases and satisfaction of mortgages nature as may be necessary or proper

My said attorneys are all persons to whom these presents shall circulate may assume that this power of attorney has not been revoked until given actual notice either of such revocation or my death.


