STATE OF OREGON, by and through it's DEPARTMENT OF FISH AND WILDLIFE, Grantor, for no monetary consideration does relinquish and forever quitclaim unto the STATE OF OREGON, by and through it's DEPARTMENT OF TRANSPORTATION, Grantee, all of Grantor's right, title, and interest in and to the property described as follows:

A Tract of Land situated in Sections 25 and 36, Township 37 South, Range 7 East, W.M., Section 1, Township 38 South, Range 1 East, W.M., and Section 6, Township 38 South, Range 8 East, W.M., Klamath County, Oregon, more particularly described as follows:

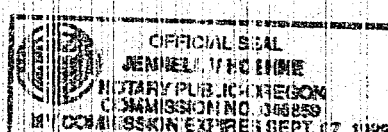
