

## DEED OF EXCHANGE

KNOW ALL MEN BY THESE PRESENTS, that certain trust deed dated January 25, 1996, executed and delivered by Patricia J. Hanson & Kenneth N. Hanson, Trustees of the Patricia J. Hanson Family Trust, as grantor and recorded on January 26, 1996, in the Mortgage Records of Klamath County, Oregon, in volume 196, at page 2304, conveying real property situated in said county described in above mentioned trust deed, having received from the beneficiary under said trust deed a written request to reconvey, reciting that the obligation secured by said trust deed has been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to said described premises by virtue of said trust deed.

BEFORE SELLING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING THE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY APPROVED USES AND TO DETERMINE ANY LIMITS ON LIENS SET AGAINST FARMING OR FOREST PRACTICES AS DEFINED IN ORS 30.930.
