re: NOTICE OF ENFORCEMENT OF ESTOPPEL BY ACQUIESCENCE

Dear Sir/Madam;

I, WAGNE H. JENKINS, now claim all right at law, regarding all matters related to the termination of my participation in the Social Security program of the United States, due to the complete failure of the above agencies to respond as directed, within the time allotted, and as required by law.

Having rescinded my signature on all Social Security documents, and having terminated participation in the Social Security program, and having surrendered my Social Security card, I do therefore inform all parties that:

- 1) My participation in the Social Security program is NOT mandatory.
- 2) Funds collected are not guaranteed to be returned to my person.
- 3) The Social Security program has no pool of funds from which to draw funds.
- 4) The Social Security Administration cannot provide me with a bond or surety to guarantee repayment of monies taken in the form of a supposedly mandatory tax.
- 5) The Fourth and Fifth Amendments to the Constitution protect me against unreasonable seizure, as well as the right NOT to have property (including monies) taken without 'Just Compensation'. Title 15 of the United States Code requires a bond or surety in the event that such is taken. I require such for the continued removal of funds unlawfully.
- 6) Title 18 USC, Section 1333 via the use of Rule 2, Federal Rules of Civil Procedure allows redress of grievance under the common law, and combines LAW and EQUITY. I will enforce said provisions without compliance from the Social Security Administration.
- 7) By Act of Congress, Section 204 of the Social Security Act (49 Stat 620) allows for recovery of unqualified individuals. Revenue Ruling 57-576 allows the return of all funds to me. I DEMAND WITHDRAWAL AND RETURN OF FUNDS THEREBY. Under the Freedom of Information Act, 5 United States Code, Section 552, I demand that you provide the records and necessary forms to accomplish this.

Pursuant to 28 usc 1746(1) and executed "without the United States", I affirm under penalty of perjury under the laws of the United States of america that the foregoing is true, correct and complete, to the best of my belief and knowledge.

I now affix my signature and official seal to all of the above affirmations WITH EXPLICIT RESERVATION OF ALL MY UNALIENABLE RIGHTS AS A FREE SOVEREIGN AMERICAN CITIZEN.
