DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated July 24, 1996; April 1, 1998, executed and delivered by Ronald D. 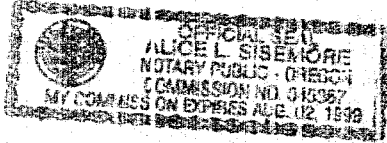
