DEED OF RECONVEYANCE

KNOW ALL BY THESE PRESENTS that the undersigned trustee or successor trustee under that certain trust deed dated AUGUST 8, 1988, executed and delivered by BARBARA J ADAMS as grantor and recorded on

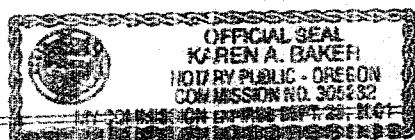
