1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Punds for Taxes and Insurance. 6. Occupancy. Preservation, Maintenance and Protection of the Property; Bostower's Loan Application; Leaseholds.
