## WARRANTY DEED

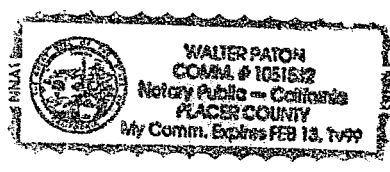

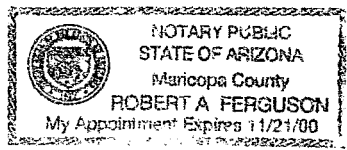
