DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated May 18, 1994; November 21, 1996, executed and delivered by Jeffrey A. 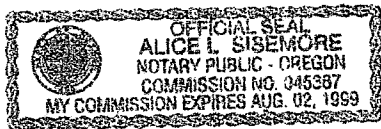
