DEED OF RECONVEYANCE

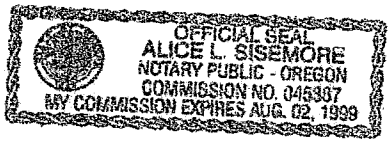

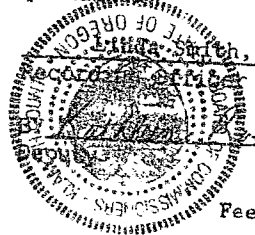
