DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated June 13, 1994, executed and delivered by Jerry L. Blaisdell & Sally R. Blaisdell, husband & wife, as grantor, Klamath First Federal Savings and Loan Association, as beneficiary, and recorded on June 17, 1994, in the Mortgage Records of Klamath County, Oregon, in volume M94, at page 19094, conveying real property situated in said county described in above mentioned trust deed, having received from the beneficiary under said trust deed a written request to reconvey, reciting that the obligation secured by said trust deed has been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to said described premises by virtue of said trust deed.

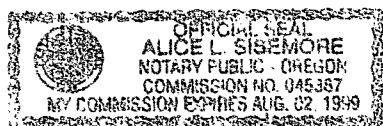
