## CONFORMANCE WITH RELEVANT KLAMATH COUNTY POLICIES: D. Ch Comments

Notice was sent out to 8 surrounding property owners as well as to 5 agencies of concern. No negative response was received from any of the notified property owners or contacted agencies. A variance shall be granted only upon finding by the review authority that it satisfies the following criteria:

- That the literal enforcement of this Code would result in practical difficulty or unnecessary hardship. The difficulty or hardship may arise from the property's size, shape or topography, or from the location of lawfully existing, buildings or improvements. A.
- That the condition causing the difficulty was not created by the applicant. That the granting of the Variance will not be detrir social to the public health, safety and В.
- welfare or to the use and enjoyment of adjacent propries and will not be contrary to the C. intent of this code.

Literal enforcement of the Code would cause unnecessary hardship because of the size of the parcel. The condition causing the difficulty was not created by the applicant.

In review of this application, it would appear not to be detrimental to the adjacent properties or to the public as there would still be adequate site distance pulling out to Gary Street Agency comments were as follows:

- Klamath County Fire Dist. No. 1 commented they have no concerns with the proposal.
