PLEASE SEE ABOVE REFERENCED TRUST DEED





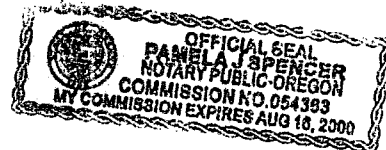
