DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated June 30, 1994; July 22, 1997, executed and delivered by Thomas B. 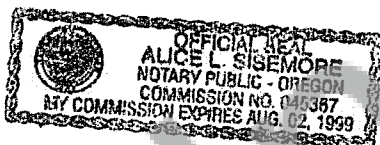
