A strip of land being 10 feet wide and situated in the West half, Northwest quarter, of Section 36, Township 38 South, Range 9 East, of the Willamette Meridian, Klamath County, Oregon, said strip being five feet each side of the following described line:

Commencing at the Center-West 1/16 Corner of Said Section 36, as shown on Major Land Partition 22-91, recorded in the office of the Klamath County Clerk; thence S.89°58'32"W., 5.00 feet; thence NORTH along a line parallel with the property line described by Quit Claim Deeds recorded in Deed Volume M91, Pages 10148 to 10151, and being shown on said Major Land Partition 22-91, to its intersection with the northeast right-of-way line of Foothills Boulevard, said intersection being the true point of beginning; thence continuing NORTH along said parallel line to its intersection with the south line of a tract of land which is the City Water Tank Site as shown on said Major Land Partition 22-91 and as described in Deed Volume M85, Page 20984. Grantors shall not erect any buildings within the easement area which would inhibit access to said City utility line(s) or cause damage to it. Grantors retain the right to utilize the easement area for roadways, driveways, parking lot and/or landscaping, except

The City, its successors or assigns, shall not be liable to Grantors for damage to the above-described premises occurring incidental to the proper use of this easement. Provided, however, in the event of damage to premises outside of and adjacent to the above-described parcels caused by the City, its successors and assigns, the party causing such damage shall repair same and place said premises in as good condition as they were

This document shall be binding upon all subsequent purchases or the above-described parcel(s), the City, and the heirs, successors and assigns, of both.
