

WARRANTY DEED

Ronald Allyn Phillips, GRANTOR, does hereby grant, bargain, sell & convey unto Mark Allyn Phillips (aka Mark Allyn Jones), GRANTEE, & Grantee's heirs, successors & assigns, an undivided $\frac{1}{2}$ interest in my undivided $\frac{1}{2}$ interest [resulting in an undivided one-sixth interest] in that certain real property, with the tenements, hereditaments & appurtenances thereunto belonging or appertaining, situated in Klamath County, Oregon, described as follows, to wit:

All interest in the North $\frac{1}{2}$ of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ Section 16, Township 31 South, Range 7 East W.M.

To have & to hold the same unto the said grantee & grantee's heirs, successors, & assigns forever as tenants-in-common with rights of survivorship.

And said grantor hereby covenants to & with said grantee & grantee's heirs, successors & assigns, that grantor is lawfully seized in fee simple of an undivided $\frac{1}{2}$ interest in the above-granted premises, free from all encumbrances excepting those of public record, & that grantor will warrant & forever defend the above granted premises & every part & parcel thereof against the lawful claims & demands of all persons whomsoever, except those claiming under the above described encumbrances.
